Privacy Policy

Facial Therapy Specialists – International (FTS-International) is a professional network.

This privacy policy explains how we use any personal information we collect about you when you become a member of FTS-International or register for any events or conferences organised by FTS-International.

FTS-International is committed to safeguarding the privacy of its members. We operate in accordance with the General Data Protection Regulations (GDPR) 2018.

The information we collect

We may collect and process the following data about you:

Information that you provide to us as a member of FTS-International, when you renew your membership with FTS-International, or register for events or conferences organised by FTS-International. This includes your name, affiliation, professional and personal contact details. If you contact us, we may keep a record of any correspondence. If you do not want any correspondence retained, you may ask for it to be deleted. However, there may be some circumstances where we may need to keep a record of the correspondence and you will be advised accordingly.

We do not collect personal information about you when you are browsing through our site.

How we use this information

As a member, we use your data to provide you with our newsletters and to inform you about network activities and events from time to time.

We also share information with researchers who seek to access the membership for research studies. FTS-International will only do this if the research is in accordance with Good Clinical Practice & Research Governance guidelines. Please contact us if you require further details. We seek your permission to do so when you become a member of FTS-International or renew your membership. You may unsubscribe from this service at any time.

Members will have their professional contact details included in the list of providers on the FTS-International website unless they have not consented to be included. If you would prefer not to be included or need to change your details, please contact us via the website.

Storing your personal data

We do our utmost to ensure that all reasonable steps are taken to make sure that your data is treated and stored securely. We will only retain your data for as long as you are a member of FTS-International. If your membership expires your personal information may still be retained by FTS-International.

If you wish FTS-International to delete your personal information once you are no longer registered as a member, please contact us via the website to request this.

Our events at times are hosted by companies that specialise in the management of conferences and events. They will collect and store details of people who have registered for those events. We may use this information to contact you regarding other network activities or events in the future. You can find out more about their privacy policies by visiting their websites.
